Shipment Information

- Option to receive shipment via UPS or pick up wine at our tasting room
- Please note that at this time we can only ship to addresses in Maryland
- Shipments require signature by an adult of at least 21 years of age
- Wines may be picked up at our tasting room on designated pick up days and must be picked up within 30 days of each release
- If you have not picked up your wine within 30 days of release and reside in the state of Maryland, we will ship your order and charge the credit card on file for any shipping and handling fees
- Out of state residents must contact us directly if wine has not been picked up within 30 days of release

Notifications

- Members will be notified via email before each quarterly release
- Email notifications will include date of release, amount to be charged to your credit card, including tax and estimated shipping fees, if applicable, or designated pick up days, if applicable
- Please note that your credit card will be charged on date of release
- It is the club member's responsibility to notify us of any account changes, including email address, billing information, and shipping address

Other Information

- There is no cost to join the club and no cancellation fee
- A valid email address and credit card are required to join
- Members opting to receive shipments must provide a shipping address within the state of Maryland
